**RESOLUTION NUMBER 023-2012
PROCLAMATION
(A Local Emergency)**

WHEREAS, Jackson County has issued a mandatory curfew beginning tonight and has recommended that all Municipalities within the County do the same.

WHEREAS, the City Council of the City of Gautier, Mississippi does hereby issue a Mandatory Curfew for the City of Gautier, Mississippi beginning at 10:00 PM tonight, August 28, 2012, and ending 7:00 AM tomorrow morning, August 29, 2012, due to anticipated flooding and high winds associated with Tropical Storm Isaac.

NOW, THEREFORE, BE IT RESOLVED that a local curfew will be in effect as stated throughout said City of Gautier, Mississippi; and

IT IS FURTHER PROCLAIMED AND RESOLVED that the City Manager or Interim City Clerk is hereby authorized to execute any and all documents necessary.
