

1 COMMISSIONER JOHNSON: Three to two.
2 That's a quorum.

3 MS. LOGAN: I'm still on the four
4 thing.

5 MR. RAMSEY: It has to get four to
6 pass.

7 COMMISSIONER WOOTEN: We appreciate
8 your patience. We appreciate all the --

9 COMMISSIONER JOHNSON: That's
10 incorrect. No. Three to two is a motion
11 to recommend to deny to the City Council.
12 It does pass.

13 COMMISSIONER DAILEY: No, it's not.
14 No, it's not.

15 MR. RAMSEY: No, it's not.

16 COMMISSIONER JOHNSON: Oh, my God.

17 MR. RAMSEY: You've got to get four
18 votes to pass this.

19 COMMISSIONER JOHNSON: That's
20 incorrect. We've had this discussion
21 before, Mr. Attorney.

22 MR. RAMSEY: I know. If you made a
23 motion to deny and only got three votes,
24 it wouldn't go to them as a
25 recommendation.

1 COMMISSIONER WOOTEN: So what we
2 voted, passed three to two.

3 COMMISSIONER JOHNSON: Which means
4 that we have forwarded a recommendation to
5 deny.

6 MR. RAMSEY: No.

7 COMMISSIONER JOHNSON: Yes, sir, it
8 does.

9 MR. RAMSEY: No, it doesn't. You've
10 got to have four votes to make a
11 recommendation.

12 COMMISSIONER JOHNSON: No, sir, you
13 do not. With all due respect, no, you do
14 not.

15 MR. RAMSEY: How many Attorney
16 General opinions do you want me to give
17 you?

18 COMMISSIONER WOOTEN: Mr. Ramsey,
19 Mr. Johnson.

20 COMMISSIONER JOHNSON: Read the
21 ordinance.

22 COMMISSIONER WOOTEN: Mr. Ramsey and
23 Mr. Johnson. All right. So it will be in
24 the minutes that the vote was three to
25 two, three to two against his motion.

1 Okay.

2 COMMISSIONER DAILEY: And it goes
3 without recommendation.

4 COMMISSIONER WOOTEN: And it goes
5 without recommendation, but the vote will
6 be recorded and it says that three of us
7 went --

8 TONY LUONG: Okay. I'm lost.

9 COMMISSIONER WOOTEN: Mr. Luong, yes,
10 sir?

11 TONY LUONG: Can I still appeal?

12 MR. RAMSEY: Yes. You have ten days.

13 COMMISSIONER WOOTEN: Yes, to go to
14 City Council.

15 MR. RAMSEY: Just go see Babs
16 tomorrow.

17 COMMISSIONER WOOTEN: Thank you,
18 Mr. Luong.

19 TONY LUONG: Thank you, guys.


