This contract shall be in effect from October 1, 2012 and will renew annually until a thirty day written notice is received by either party for cancellation.

There after, Southern Pest Control Agrees to render not less than one treatment Every Other Month at the above described address to control the following pest: roaches, ants, mice and rats (excludes fire ants)

This agreement shall be in effect from October 1, 2012 and will renew annually until a thirty day written notice is received by either party for cancellation. Additional service charges will be made for pest not listed above. Purchaser agrees to make premises available to be serviced. This agreement does not guarantee against present or future pest or rodent damage to buildings or contents or provide for repairs or compensation thereof.

Should the purchaser fail to fulfill the agreement, a cancellation fee in the amount of \$311.90 shall become due and payable to Southern Pest Control. Purchaser agrees to pay all cost of collecting; including a reasonable Attorney's fee in the event charges accruing here under are collected by law or through an Attorney at Law. Any statements other than those which are contained in the agreement are void.
