There came on for consideration of the Mayor and Members of the Council of the City of Gautier, Mississippi, the following:

**RESOLUTION NUMBER 031-2013
PROCLAMATION
(A Local Emergency)**

WHEREAS, the City Council of the City of Gautier, Mississippi does hereby find that the conditions of extreme peril to the safety of persons and property have arisen within the City of Gautier, Mississippi, due to the existence and impending threat of tropical storm force winds and rain due to Tropical Storm Karen.

WHEREAS, the aforesaid conditions of extreme peril warrant and necessitate the proclamation of the existence of a local emergency in order to provide for the health and safety of the citizens and the protection of their property within the affected jurisdiction.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND RESOLVED that in accordance with Section 33-15-17(d), Mississippi Code of 1972, as amended, a local emergency does exist throughout said City of Gautier, Mississippi; and

IT IS FURTHER PROCLAIMED AND RESOLVED that said local emergency shall be deemed to continue to exist until such local emergency is no longer in effect and proclaimed terminated by the City Council of the City of Gautier, Mississippi.

IT IS FURTHER PROCLAIMED AND ORDERED that all City agencies and departments shall render all possible assistance and discharge their emergency responsibilities as set forth in the July 2011 Emergency Operations Plan (EOP).

IT IS FURTHER PROCLAIMED AND ORDERED that the City Manager or City Clerk is hereby authorized to execute any and all documents necessary to provide for the health and safety of the citizens and the protection of their property in accordance with responsibilities set forth in the July 2011 Emergency Operations Plan (EOP) and/or in furtherance of the protection of those interests in accordance with the spirit of the EOP at the time of its adoption.
