RESOLUTION NUMBER 000-2014

WHEREAS, the Gautier Men's Club has requested the Mayor and Members of the Council of the City of Gautier, Mississippi to provide in-kind services and financial support from the City of Gautier, Cultural Services Department, and the Police Department, for the Gautier Men's Club's 25th Annual Mardi Gras Parade to be held Saturday, February 22nd at 7:00 PM.

WHEREAS, the Mayor and Members of the Council have determined that this event is an economic development tool to bring favorable notice, opportunities, possibilities and resources to the City of Gautier.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Members of the Council of the City of Gautier, Mississippi, as follows to-wit:

SECTION 1. In-kind services are hereby authorized from the Police Department to provide four (4) traffic officers and six (6) patrol officers at five (5) hours each for traffic control and security for this event. Reserve officers have also been scheduled to assist with the event. The Police Department estimates their in-kind contribution will equal \$1,089.00; and

SECTION 2. In-kind services are hereby authorized from the Cultural Services Division to provide labor (2 employees @ 15 hours each) for set-up and use of barricades and bleachers for the judging area, port-a-lets and clean-up of the parade route after the event. The Cultural Services Division estimates their in-kind contribution to be \$640.00. The total cost of City in-kind services is therefore estimated at \$1,729.00.

SECTION 3. The Gautier Men's Club request for financial support from the City of Gautier for the Mardi Gras Parade in the amount of \$1,416.00 is hereby authorized.

SECTION 4. The City Manager or City Clerk is authorized to execute any and all documents necessary.
