

Good morning. I wanted to make you aware we had another break-in at Buddy Davis last week, which prompted me to dig up this quote from a few weeks ago.

The current league has installed (at their cost) a simple security system, but I have requested to expand the coverage into the restrooms and the meeting room area (see attached quote). At the same time, Grandview Security has agreed to donate a multi-camera system with a DVR to hopefully catch the vandals on tape. We will enclose the cameras with a simple steel cage or box to help cut back on camera damage.

We would like to see if the County would pick up the tab on the security system install and first year of monitoring, with the presumption we will pay for monitoring in the following years.

I also have a price forthcoming for a new entry gate & fencing along part of the North side, which is where there seems to be a lot of 4wheeler type activity entering the property. I will forward this to you as soon as I get this.
