RESOLUTION NUMBER 000-2015

WHEREAS, the Gautier Mullet & Music Fest Committee has requested the Mayor and Members of the Council of the City of Gautier, Mississippi to provide in-kind services from the Cultural Services Department, Human Resources Department and Police Department, for the 25th Annual Gautier Mullet & Music Fest to be held Saturday, October 17th and Sunday, October 18th.

WHEREAS, the Mayor and Members of the Council have determined that this event is an economic development tool to bring favorable notice, opportunities, possibilities and resources to the City of Gautier.

WHEREAS, the Mayor and Members of the Council have determined that the donation of in-kind services have been matched by other existing funds.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Members of the Council of the City of Gautier, Mississippi, as follows to-wit:

SECTION 1. In-kind services are hereby authorized from the Police Department to provide eight (8) full-time officers (total of 96 hours) for security and traffic direction; Estimated costs will equal \$2,213.88; and

SECTION 2. In-kind services are hereby authorized from the Cultural Services Division and Human Resource Department for the set-up of barricades; clean-up during and after the event; trash receptacles/bags; staging; and fencing; and mowing; Estimated costs is approximately \$2,854.28 in in-kind costs for the requested materials, approximately 106 hours of labor (3 employees), and the use of equipment; and

SECTION 3. the total estimated costs for in-kind services is \$5,068.16.00 and 202 estimated hours; and

SECTION 4. the City Manager or City Clerk is authorized to execute any and all documents necessary.
