**Summary Explanation:** Approval of the replacement MOU with the Mississippi Department of Transportation for the 2013 Safe Routes to School funding. A grant totaling \$206,000 was awarded for infrastructure improvements and activities designed to encourage and enable children to walk and bicycle safely to College Park Elementary School. The grant requires a 20 percent match, with Jackson County providing \$15,000 of the local match.
