Summary Explanation: Approval of Supplemental Agreement #2 for the Streetscape Phase III project to allow for additional expenses to relocate plantings. This supplemental agreement adds \$3,700 to the contract amount to relocate 79 shrubs and 25 trees from Hwy. 90 to other areas within the project limits. The relocation is necessary to ensure that the visibility of the ground-mounted signs at the Methodist church and Mexican restaurant are unobstructed.
